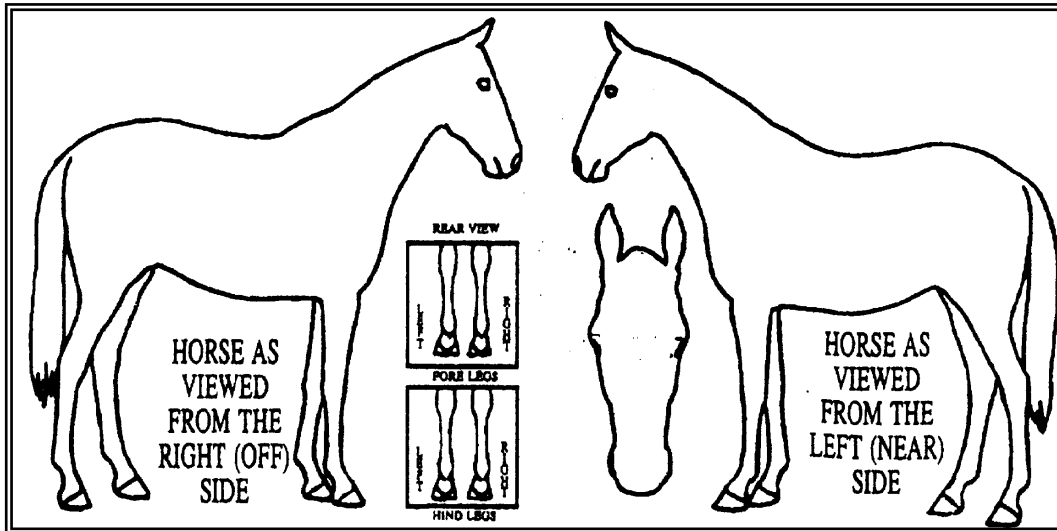

TERMS AND CONDITIONS of AGISTMENT

1. Advance agistment payments will be made at agreed regular intervals (weekly, or fortnightly). Please circle relevant timeframe.
2. Full vaccination history of above mare must be submitted prior to arrival. Mares **MUST** be vaccinated for tetanus/strangles, and EHV 1,4. Veterinary certification must be provided to prove this.
3. All horse upon arrival on the property will be integrated into a standard worming procedure (Equimec or Equimax every 6-8 weeks), unless otherwise agreed.
4. Horses arriving on the property will undertake a period of quarantine until the Management is satisfied that the horse is carrying no infectious diseases.
5. The Management will tolerate **NO FORM** of **NEGLECT OR MISTREATMENT** to **ANY** animal on the property, under penalty of eviction.
6. Horses will be shod or trimmed at regular intervals at mare owner's expense.
7. The Management reserves the right to move horses due to maintenance, spelling or safety requirements.
8. The Management will not be held responsible for any lost/damaged property or personal injury incurred whilst on the premises.
9. While all care will be taken, the Management will not be held responsible for any veterinary incident to the above-mentioned mare. Should the mare owner(s) be uncontactable, and the extremity of the circumstances dictate, the Management reserves the right to call the preferred vet. Should the preferred vet be unavailable, another vet will be called.
10. Failure to meet with the above terms and conditions may result in eviction, or, in the case of outstanding agistment fees of 1 month, a warning notice will be issued. If fees are not paid within 30 days, the above horse will be sold to recuperate any monetary loss incurred by Gypsy Lodge Equestrian Centre.

CONDITIONS OF SERVICE- Live Cover
For mares being bred on stud at Gypsie Lodge Equestrian Centre

1. Service fee is payable prior to service, and are non-refundable or transferable.
2. A \$250.00 booking fee is payable prior to arrival of mare.
3. In the case that the stallion should be injured to prevent breeding, die or be sold, the mare owner is entitled to a full refund (excluding the handling fees, booking fees and agistment costs already incurred by the mare).
4. Leasa Stephen and Gypsie Lodge Equestrian Centre will take all care for mares being served but no responsibility for any injuries should they occur. Owners are advised to be aware of the risks involved with naturally breeding horses.
5. Mare owners are advised that a free return does not guarantee that a live foal will be born by the mare being bred. This term entitles the mare owner to a return breeding for the same mare to the same stallion, the following year. This applies only in the case that the mare should a) fail to conceive, b) abort the foetus or c) the foal die within 24hrs of birth. A veterinary certificate must be supplied within 7 days of vet examination.
6. Should both Mare Owner and Stallion Owner agree that said mare is not suitable, another mare may be substituted. The Free Return is valid for the following season only, and is **not** transferable to another party.
7. Should the mare owner fail to have a veterinarian examine the pregnancy for twins or abortions at or before twenty one days (21) after insemination, and between forty (40) and sixty (60) days after conception, the free return will be void. It is the responsibility of the mare owner to assist in maintaining the pregnancy with regular veterinary checks. Gypsie Lodge Equestrian Centre and Leasa Stephen will not honour Free Returns when the mare owner has neglected to undertake appropriate examinations.
8. Leasa Stephen and Gypsie Lodge must be notified in writing within seven (7) days of the results of the pregnancy tests as outlined above (point 7) or the free return will be void.
9. Gypsie Lodge and Leasa Stephen will not honour Free Returns when the mare loses a pregnancy due to poor health caused from owner's neglect. Appropriate feed, water and shelter should be available to the pregnant mare at all times.
10. In the event of abortion or death of foal prior to 24hrs after birth, the Handling Fee (\$150 per cycle for 09/10 season-subject to change) will be charged again upon exercising the Free Return the following breeding season.

11. The breeding season consists of late October to end of February each year. Mares must be bred within this period unless agreed to by Stallion Owner.

12. The Stud exercises the right to refuse any mare for breeding for whatever reasons.

13. Any mare requiring treatment and/ or professional handling in the case of them being difficult to handle will be treated as such. The use of sedatives (Vet administered) or twitches will be used as appropriate restraints during serving. The mare owner will be responsible for payment of all drugs used and associated costs. The stud will take no risks with mares that are a danger to themselves or the stallion.

14. Mare owners are required to have their mares assessed for breeding soundness before being sent to the Stud. Veterinary Certification proving the mare free from infection and vaccination status for tetnus/strangles and EHV 1,4 MUST be provided to Gypsie Lodge prior to the mare arriving.

15. The Stud requests the right to administer hormone treatment for breeding and pregnancy if required on Veterinarian advice. All treatments will be explained to the mare owner, and costs will be billed to the mare owner.

16. It is mandatory that mare owners have their mare scanned 14-21 days after insemination to determine their pregnancy status, and again at 40-60 days.

17. All accounts are to be paid in full before the mare will be allowed to leave the Stud. Service certificates cannot be issued without appropriate registration papers or proof of identity. All accounts must be paid in full prior to service certificates being issued.
